### CHARLIE KILLAM SCHOOL MODERNIZATION BUDGET

Secretary-Treasurer Schulte reviewed the proposed budget for the completion of the modernization of the Charlie Killam School. Mr. Schulte noted that the City of Camrose requires that Battle River Regional Division #31 do a Traffic Management Study. The timeline for completion of the modernization is November or December, 2003.

### TRUSTEE REPORTS

Vice-Chairman Herder reported that she will be meeting with Halvar Jonson, MLA, and has met with the school administrators in her ward. She will be setting up meetings with the municipal leaders and, in some cases, community group leaders to pass on the messages outlined in the Board's communications plan.

Trustee Oberg noted that he and Chairman Poyser met with Doug Griffiths, MLA, who expressed his keen interest in rural Alberta. Mr. Oberg also met with the School Council at Heisler School, and noted that the School Council is planning a public meeting on March 19, 2003 with respect to multi-aged education.

Trustee Fitzmaurice-Johnson noted that she has attended several presentations at Camrose Composite High School (CCHS) and has had

informal discussions with teachers. Ms Fitzmaurice-Johnson has also been involved in the work of the Drug Response Task Force, attending a meeting in Tofield recently, and will be attending another scheduled at Killam in March.

Trustee Zeniuk noted that, although she has not set up any formal meetings, she has had informal conversations with school personnel and has been fielding phone calls and responding to e-mails.
